

To the editor:

y name is Lynn Gallant-Blackburn. I am Paula Gallant's older sister (and mother figure for half her life, as our dad died at 49 and our mom died at 46 from cerebral aneurysms in Glace Bay). Paula Gallant is the 36-year-old school teacher who was murdered and found dead in the trunk of her car by my family in her school parking lot on Dec. 27, 2005.

I am writing this in the hopes that you will print my Letter to the Edi-

tor and take the credit for your respectful and accurate reporting. *The Daily News* (on the mainland) and *The Cape Breton Post* (our hometown newspaper) are keeping this story alive, and that is critical to the investigation and to my family.

Paula was a victim of a horrific crime, and the truth needs to be discovered. It could be that one story, one tip, one witness could lead police to the truth ... and put closure on this horror.

People need to know that Paula could have been anyone's sister: our

lives were that basic. We were raised with strong values and ethics: work hard, be honest, be kind, make people laugh, be respectful ... just try to live a good life.

And for her life to end, at 36, with a one-year-old daughter (her Anna, her Angel) in the way it did is simply wrong. Her family, friends, colleagues and students have lost so much and as each day passes, and people move on, we fear that you will forget her. So, please print my letter and please keep reporting the stories.

In closing, it is important for you to know that I appreciate your reporting integrity and speak very highly of this at every opportunity presented. Since the first day of this horrific tragedy, there has been so much speculation about the murder

A reporter by the name of Dan Arsenault (who works for *The Chronicle Herald*) wrote a story the day after Paula's murder that was very disrespectful to our family. Suggestions of suicide, depression and unhappiness could not have been farther from the truth.

We spent the two weeks following her death defending her state of mind. But on the 14th day, when the police confirmed homicide, those awful stories were still ingrained in people's minds. This type of erroneous and distasteful reporting is completely unacceptable, and I will never give *The Chronicle Herald* one minute of my time.

Their actions have insulted so many and when I tell my story (which I will do when this murder is solved), people like Dan Arsenault and *The Chronicle Herald*, will too, be highlighted for the wrongs they did to the Gallant Family in the days following Paula's murder.

ing to allay our fears.

Awaiting justice 23/22

We are approaching three months since the murder of Paula Anne Gallant.

In many ways, Paula lived every day to the fullest; however, she in no way expected that Dec. 27 would be the last day she would ever gaze into her daughter Anna's eyes.

Three months, and Anna is without a mother.

Three months, and the person or persons responsible for Paula's murder has not been sent to justice.

We all have a role to play in seeing justice is served in this case

and we have to keep in mind that someone has to speak for Paula.

The police have to do their work and ensure all the evidence is gathered properly.

The press has to probe more, ask questions, keep this story in the forefront until all the answers are found.

Friends and family have to come forward if they have anything which could be helpful to the investigation. If anyone in the community saw or heard anything around the school or in the Timberlea area on Dec. 27, contact the police or Crime Stoppers.

We all have a role to play.

When there are no words, there are no truths. Who will speak for Paula Gallant, now that she is unable? Who will speak for Anna, too young to talk, too young to be without her mother?
